## **New Topics**

**3a. Dark Skies Proclamation:** Piedmont Dark Skies and a number of local stakeholders have reached out to Town Staff and the Mayor requesting a proclamation from the Town of Scottsville for International Dark Sky Week, April 2-8, 2024. Attached is their request to the Town Council and a draft proclamation presented by the Piedmont Dark Skies and stakeholders. The proclamation asks that: "that residents use outdoor lighting in a mindful manner and that the Town of Scottsville enforce the dark sky protections in the town ordinances."

Town Staff works to support the reduction of light pollution and actively enforce the dark sky ordinances established in the Town of Scottsville ordinances, in addition the Architectural Review Board reviews the lighting of signage within the Entrance Corridor and Historic Overlay District to reduce light pollution and maintain the character of Scottsville.
